C4N-NIPN Global Support mission in Ivory Coast

Between 16 and 21 January 2022, Global Support conducted a mission in Ivory Coast to discuss challenges to the operationalization of NIPN with its host institution SE-CONNAPE. The mission aimed to support the NIPN platform team to take stock of past actions and capitalize on future opportunities, in view of the implementation of Phase II. Results achieved during the mission include:

- review of main achievements from NIPN I
- identification of opportunities for 2022
- identification of recommendations / measures to improve, strengthen and maintain the NIPN platform.

Closure of the NIPN Platform in Bangladesh

C4N-NIPN Global Support delivers Lives Saved Tool costing training in Ivory Coast

Between 8 and 11 March, Global Support delivered the second part of the Lives Saved Tool (LiST) training in Grand-Bassam. The workshop focused on using LiST to estimate the costs of six nutrition intervention packages formulated during the first training that took place in 2021. At the end of the training, two of the six packages were identified as the most cost-effective and they will be presented to decision makers during the upcoming revision of National Plan of Action for Nutrition. On 9 and 10 March, Burkina Faso and Ivory Coast platform teams presented at NIPN's first webinar in 2022. The two countries shared their experience on the Lives Saved Tool (LiST) training delivered by Global Support in mid-2021. The modelling tool was used for different purposes: i) to support strategic planning in Ivory Coast and ii) evaluate the

potential impact of the National Multisectoral Plan of Nutrition in Burkina Faso.


Following the outcomes and recommendation of the mission organized by Global Support, the NIPN team in Ivory Coast organized a strategic retreat with the main actors of NIPN Phase II to reflect on the results of the 2021 mid-term review and prepare for implementation. During the retreat the following results were achieved:

- i) taking stock of the activities of NIPN I,
- ii) identification of bottlenecks and formulation of recommendations,
- iii) development of a workplan for the period January June 2022.
- iv) capacity strengthening in administrative and financial processes,

NIPN Ethiopia has now published online the "NIPN Information and Knowledge Management Approach". The document aims to:

NIPN Uganda supports the 2021 Nutrition Governance Indicators

Baseline Survey

La PNIN en Ouganda soutient l'enquête de base sur les indicateurs de gouvernance en matière de nutrition de 2021



The NIPN Data Analysis Unit (DAU) supported the Uganda Bureau of Statistics in conducting the 2021 Nutrition Governance Indicators Baseline Survey. The DAU supported the development of an all-inclusive questionnaire. The purpose of the survey was to generate comprehensive data and baseline values to support the strengthening of nutrition enabling environment for the scale-up of nutrition specific and sensitive services. To date, three-quarters of the field

data collection has been completed and analysis of data from 176 districts, municipalities and regional cities has been initiated.

NIPN Guatemala advocates for the scale-up of information systems at the sub-national level

La PNIN au Guatemala plaide en faveur du renforcement des systèmes d'information au niveau infranational



Since the start of Phase II in 2021, NIPN Guatemala has engaged in various exchanges with representatives of the Food and Nutrition Secretariat of 10 of the departments prioritized by the national strategy "the Great Crusade for Nutrition" to advocate and support the scale-up of the department and municipality information systems (respectively known as SIDESAN and SIMSAN). During these exchanges, department delegates recognized the benefits of scaling-up the information systems to strengthen

evidence-based decision-making for food and nutrition security at local level.

NIPN Burkina Faso validates analysis plan

La PNIN au Burkina Faso valide le plan d'analyse

Between 7 and 11 March 2022, NIPN actors gathered in Ziniare to elaborate and validate the analysis plan to answer the sixth question prioritized as part of the policy questions formulation process. The question addresses the evolution



of Infant and Young Child Feeding (IYCF) and stunting indicators in the nine regions of Burkina Faso where IYCF promotion interventions are implemented. The meeting aimed at identifying the data needed to answer the research question and defining variables and indicators required to conduct the analysis. At the end of the meeting, an analysis plan for the 6th research questions was formulated. Once

the analyses will be concluded, the results could potentially be used to advocate for the scale-up of the IYCF promotion package.
